- 4. All material remains the property of Fencing Manufacturers (Aust)/Betta Balustrades until such times as materials have been paid.
- 5. The installer shall not be liable for damages to property, e.g. gas, water, electricity, telephone installations, steel reinforcement although every care shall be taken.
- 6. Power is required by customers for all Automated gates.
- 7. This quote does not include demolish and remove of old fence or clearing of tree, shrubs etc unless specified.
- 8. Customer must be present to define fence line on day of installation otherwise no responsibility taken.
- 9. Installation around pools the client shall thoroughly clean their pool directly after installation.
- 10. Unless specified on quotation, if there is rock or similar obstructing materials e.g. roots, stumps etc there shall be additional charges.
- 11. Every endeavour shall be made to have the contract completed by a given date, however, the Fencing Manufacturers (Aust)/Betta Balustrades shall not be liable to penalties or damages for failure to complete contract by given date.

- 16. If installation is cancelled due to weather. Installation will be re booked for the following suitable day.
